FCC Associates' is dedicated to making sure the plan(s) noted above (referred to as the "Plan") effectively assists your preparations for a more financially secure retirement.

The Plan offers a wide range of investment options, providing you the opportunity to develop an individualized investment strategy. Periodically, the funds in the Plan are reviewed ensuring an appropriate range of options is offered.

As a result of this review, we are pleased to inform you we are enhancing the investment options offered in the Plan. We encourage you to take advantage of all the benefits the Plan offers.

What You Need to Know

Fee Changes

There are fees associated with the administration of retirement plans. We are committed to disclosing to you the fees that your account will be charged.

Fee Levelization

In order to make Plan expenses more transparent and more equitable among Plan participants, the Plan will be implementing Fee Levelization, effective October 2020.

Fee Levelization allows the crediting of certain types of revenue received by Prudential to participant accounts. Since the amount of revenue varies from fund to fund, the ultimate share of plan expenses paid by participants may vary depending upon investment mix. Once Fee Levelization takes effect, you may see a credit labeled "Fee Levelization Credit," on your quarterly statement.

Asset-Based Participant Fee Implementation

Effective with the implementation of Fee Levelization, an asset-based participant fee of 0.30% will be imposed on all investment options available in the Plan. Asset-based participant fees are the same percentage for each participant, and the same percentage for each investment to which they apply. The fees are for recordkeeping and/or administrative services provided to the plan and are annual fees which are deducted from your account on a quarterly basis. However, this fee will be calculated based on your fund balance on the last business day of the quarter following the effective date and will then be deducted from your account.

Guaranteed Income Fund Fee Change

Effective after 4 p.m. ET **October 1, 2020**, the asset charge on the Guaranteed Income Fund will be **reduced** from 0.50% to 0.00%. Therefore, the net annualized interest crediting rate for the Guaranteed Income Fund will be 1.65% through **December 31, 2020**.

Guaranteed Income Fund Fee Change Impact Example

Any fees and expenses that you pay will have an impact on your retirement savings over time. The following is a hypothetical example of the potential impact of the fee change. **Note:** before a fund's rate of return is reported to Plan participants, fees have already been removed; performance is reported "net" of fees.

If you do not take action, any remaining assets in any funds being removed, and all future contributions to those funds, will automatically change.

FCC ASSOCIATES' RETIREMENT PLAN QUALIFIED DEFAULT INVESTMENT ALTERNATIVE NOTICE

This is an annual notice and only applies to the Plan Year beginning on January 1, 2020.

Right to direct investment/default investment. You have the right to direct the investment of elected deferrals and other accounts allowed by your Plan (your "directed accounts") in any of the investment choices explained in the investment information materials provided to you.

We encourage you to make an investment election to ensure that amounts in the Plan are invested in accordance with your long-term investment and retirement plans. However, **if you do not make an investment election**, then the amounts that you could have elected to invest will be invested in a default investment that the Plan officials have selected.

Description of default investment. The default investment is:

Right to alternative investment. If the Plan invests some or all of your elected deferrals and other accounts in the default investment, then you have the continuing right to direct the investment of your elected deferrals and other accounts allowed by your Plan in one or more of the other investment choices available to you as explained above. You may change your investments at any time.

No transfer fees or expenses will be charged if you elect an alternative investment within 90 days after first being subject to the default investment. However, your account will be adjusted for any investment gains or losses.

If you are invested in the Plan’s QDIA, as specified below, this notice applies to you.

Effective **October 1, 2020**, the Plan is modifying its QDIA by reducing the asset charge on the Guaranteed Income Fund from 0.50% to 0.00%.

Effective **October 5, 2020**, the Plan is modifying its QDIA by replacing the following funds within the GoalMaker portfolio model. Any portion of your GoalMaker account and future contributions invested in the old funds will go to the new funds.

Additionally, effective **October 5, 2020**, the Plan is adding to its QDIA the Fidelity 500 Index Fund within the GoalMaker portfolio model.

If you do not have investment allocations on file for future contributions, you will need to make such an election if you wish to stop the transfer of your existing account balance to this QDIA. This applies even if you may no longer make future contributions to the Plan or had previously made an investment allocation in the past but may no longer have one on file. This also applies to terminated participants, alternate payees, and beneficiaries who have no investment allocations on file. Please confirm investment elections for your account on the participant website.

The Plan Sponsor has designated an age-appropriate Moderate GoalMaker portfolio as the QDIA for the Plan. This notice provides information about changes to this default investment fund. GoalMaker creates model asset-allocation portfolios based on age, risk tolerance, and years to retirement. You will be placed in one of the GoalMaker portfolio models based on the information in our records regarding your current age, the number of years you have left until an assumed retirement age of 65, and a Moderate risk tolerance level.

GoalMaker also includes a feature called “automatic rebalancing.” This feature automatically rebalances your account investments **quarterly** so that your account remains diversified across a range of investments, according to specific percentages as shown below. GoalMaker’s automatic rebalancing feature also automatically adjusts your investments as you get closer to retirement, as shown in the following table.

THE PLAN’S QUALIFIED DEFAULT INVESTMENT ALTERNATIVE (“QDIA”):

A GoalMaker® Portfolio

As described above, the GoalMaker portfolio automatically rebalances **quarterly** so that your investments remain diversified across a range of investments, but according to specific percentages as shown in the following table. GoalMaker’s automatic rebalancing feature also automatically adjusts your investments as you get closer to retirement, as shown in the following table.

Your investment returns are reduced by various fees and expenses. The expense ratio column shows these charges as an annual percentage. Fund Fact Sheet User's Guide

This guide will help provide a glossary of terms and benchmark definitions commonly found on fund fact sheets.

In providing this information Prudential Retirement is not undertaking to provide impartial investment advice, or to give advice in a fiduciary capacity. Prudential Retirement may benefit from advisory and other fees paid to it or its affiliates for managing, selling, or settling of the Prudential mutual funds and other investment products or securities offered by Prudential Retirement or its affiliates. Investment vehicles sponsored or managed by a Prudential Retirement affiliate generate more revenue for the Prudential enterprise than non-proprietary investment vehicles. Prudential Retirement's sales personnel generally receive greater compensation if plan assets are invested in proprietary investment vehicles. Prudential Retirement may benefit directly from the difference between investment earnings of Prudential Retirement's stable value funds and the amount credited to deposits in those funds. Prudential Retirement may also benefit from broker-dealer or other entities' co-sponsorship of Prudential conferences.

Allocation

We break down the investment holdings into general investment classes. The pie chart shows how much emphasis is placed on stocks, bonds or cash. We also show how much is held in foreign stocks. Bond investments replace the portfolio allocation chart with the following:

Quality Distribution: We reveal the quality of the bonds in a bond-heavy portfolio, from least risky to most risky, with the percentage assigned to each.

Benchmark Performance

The holdings and characteristics may differ from those of the benchmark(s), and such differences may be material. Factors affecting portfolio performance that do not affect benchmark performance may include portfolio rebalancing, the timing of cash flows, credit quality, diversification and differences in volatility. In addition, financial indices do not reflect the impact of fees, applicable taxes or trading costs which reduce returns. Unless otherwise noted, financial indices assume reinvestment of dividends. You cannot make a direct investment in an index. The statistical data regarding such indices has not been independently verified.

Expense Ratio

The net and gross expenses shown include the total operating expenses of the funds and the indirect expenses of the funds' underlying portfolios. Your investment returns are reduced by various fees and expenses. For each plan investment option, the "Expense Ratio" presentation shows these charges as an annual percentage. Depending on the type of investment, these charges are paid to Prudential or to unaffiliated mutual fund complexes or bank collective trusts. For mutual funds the Expense Ratio is not reduced by any fee or expense waivers from the fund complex (i.e., Gross Expense Ratio), and therefore the actual Expense Ratio may be lower. For other investment options, including separate accounts and bank collective trusts, the benefit of any waivers is reflected in the Expense Ratio (i.e., Net Expense Ratio). Not all funds charge an Expense Ratio. Please see specific fund factsheets for details.

Fund/Portfolio Category

Morningstar, an investment research and investment management firm, assigns each mutual fund to a category, based on their actual investment style as measured by their underlying portfolio holdings over the past three years. Categories for Manager of Managers separate accounts are determined by Prudential.

Morningstar Style Box

The Morningstar Style Box™ reveals a fund's investment strategy. For equity funds the vertical axis shows the market capitalization of the long stocks owned and the horizontal axis shows investment style (value, blend, or growth).

For fixed-income funds, the vertical axis shows the credit quality of the long bonds owned and the horizontal axis shows interest rate sensitivity as measured by a bond's effective duration.

Morningstar Style Box (continued)

Morningstar seeks credit rating information from fund companies on a periodic basis (e.g., quarterly). In compiling credit rating information Morningstar accepts credit ratings reported by fund companies that have been issued by all Nationally Recognized Statistical Rating Organizations (NRSROs). For a list of all NRSROs, please visit <http://www.sec.gov/divisions/marketreg/ratingagency.htm>. Additionally, Morningstar accepts foreign credit ratings from widely recognized or registered rating agencies. If two rating organizations/agencies have rated a security, fund companies are to report the lower rating; if three or more organizations/agencies have rated a security, fund companies are to report the median rating, and in cases where there are more than two organization/agency ratings and a median rating does not exist, fund companies are to use the lower of the two middle ratings. PLEASE NOTE: Morningstar, Inc. is not itself an NRSRO nor does it issue a credit rating on the fund. An NRSRO or rating agency ratings can change from time-to-time.

For credit quality, Morningstar combines the credit rating information provided by the fund companies with an average default rate calculation to come up with a weighted-average credit quality. The weighted-average credit quality is currently a letter that roughly corresponds to the scale used by a leading NRSRO. Bond funds are assigned a style box placement of "low", "medium", or "high" based on their average credit quality. Funds with a low credit quality are those whose weighted average credit quality is determined to be less than "BBB-"; medium are those less than "AA-", but greater or equal to "BBB-"; and high are those with a weighted-average credit quality of "AA-" or higher. When classifying a bond portfolio, Morningstar first maps the NRSRO credit ratings of the underlying holdings to their respective default rates (as determined by Morningstar's analysis of actual historical default rates). Morningstar then averages these default rates to determine the average default rate for the entire bond fund. Finally, Morningstar maps this average default rate to its corresponding credit rating along a convex curve.

For interest-rate sensitivity, Morningstar obtains from fund companies the average effective duration. Generally, Morningstar classifies a fixed-income fund's interest rate sensitivity based on the effective duration of the Morningstar Core Bond Index (MCBI), which is currently three years. The classification of Limited will be assigned to those funds whose average effective duration is between 25% to 75% of MCBI's average effective duration; funds whose average effective duration is between 75% to 125% of the MCBI will be classified as Moderate; and those that are at 125% or greater of the average effective duration of the MCBI will be classified as Extensive. For municipal bond funds, Morningstar also obtains from fund companies the average effective duration. In these cases static breakpoints are utilized. These breakpoints are as follows: (i) Limited: 4.5 years or less; (ii) Moderate: more than 4.5 years but less than 7 years; and (iii) Extensive: more than 7 years. In addition, for non-US taxable and non-US domiciled fixed income funds static duration

breakpoints are used: (i) Limited: less than or equal to 3.5 years; (ii) Moderate: greater than 3.5 and less than equal to 6 years; (iii) Extensive: greater than 6 years.

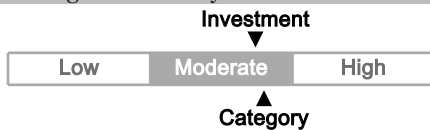

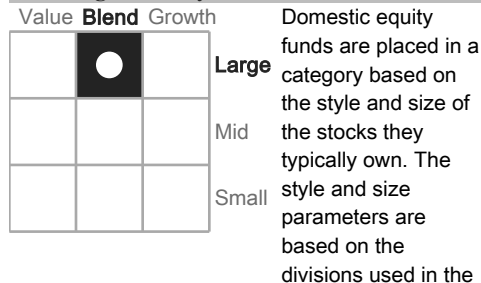

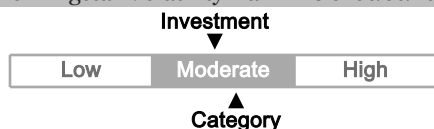

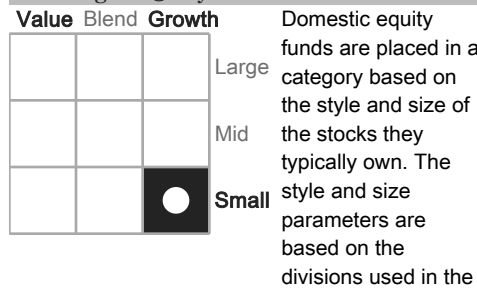

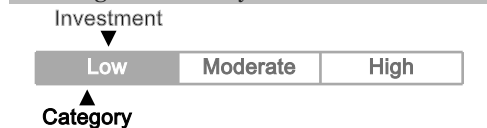

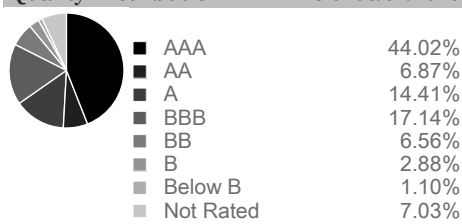

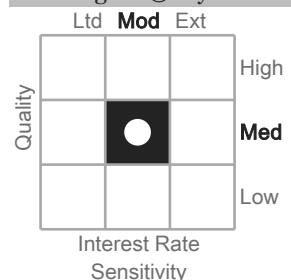

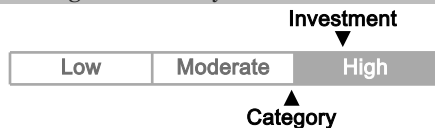

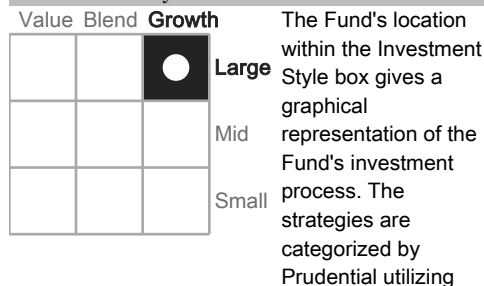

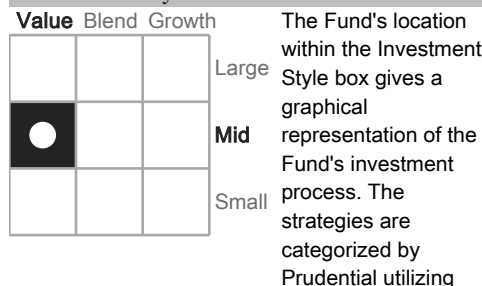

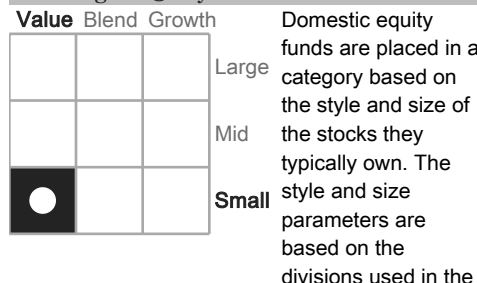

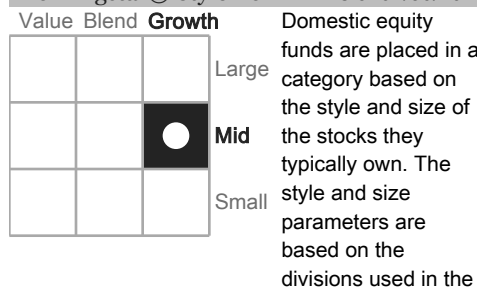

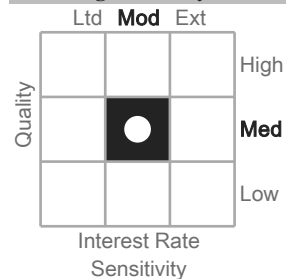

Description / Objective

The Guaranteed Income Fund (GIF) is a Stable Value fund designed to provide safety of principal, liquidity, and a competitive rate of return.

The Fund Offers

- > Stability of crediting rate
- > Guaranteed protection of principal and accumulated interest from market volatility
- > Intermediate-term fixed income returns

Features

- > Principal and accumulated interest are fully guaranteed by Prudential Retirement Insurance and Annuity Company (PRIAC).
- > The guaranteed interest rate is announced in advance and is guaranteed for a six-month period. A minimum rate will apply.
- > GIF invests in a broadly diversified, fixed-income portfolio within PRIAC's general account. The portfolio is primarily invested in public bonds, commercial mortgages and private placement bonds.

Other/Risks

In most circumstances, Participants may not directly transfer amounts from Guaranteed Income Fund to a competing fund. A transfer out of this investment must be directed to and remain in a non-competing fund for a period of 90 days before it can be invested in a competing fund. Competing funds are generally short-term fixed income investments, money market funds or stable value investments that may be available as a Plan investment option. However, the transfer provisions and competing fund definitions may differ depending on the provisions of the group annuity contract.

A "pool" consists of similar contracts that are funded with us in the same calendar year. Prudential reserves the right to defer certain withdrawals from GIF assets if the amount of withdrawals and transfers to date for that pool is greater than 10% of the pool's beginning balance for that calendar year. However, distributions resulting from a plan participant's termination of employment, retirement, death or disability, hardship withdrawals and minimum required distributions will always be paid in full and not deferred.

Additionally, when your Plan's group annuity contract terminates, payments from the Guaranteed Income Fund may be delayed depending on the terms of the group annuity contract (which may result in a delay in payments by the Plan. The Customer Service Center can answer questions regarding these provisions applicable to a Plan.
